Self-nominations are now open for three (3) owner positions on the UOATC Board of Directors. This will be for a two (2) year term of office which would begin on December 2, 2023.

All Directors will be required to sign the Director's Fiduciary Responsibility Resolution which outlines the code of conduct. Directors will typically have the option to attend meetings in person or virtually (by Microsoft Teams).

All candidates will be vetted by a nomination committee. In evaluating nominees, the Committee will be considering each nominee's history of involvement in the Suncadia community, attendance at Board and Annual meetings, participation in Suncadia community events, and service on Suncadia committees/task forces/subcommittees. Candidates may be interviewed to ascertain if the candidate understands the various levels of governance and the scope of authority of their position on the Board. Community Associations Management will be offering all candidates a course in "Suncadia 101" to help them better understand the complex governance within the community. This course is also available in a PowerPoint presentation.
